- Age Criteria: Maximum 30 years as on 03.08.2018 (last date of receipt of application). Relaxation in age would be admissible as per rules of Govt. of India.

3. Eligibility Criteria:

NIS Diploma or equivalent in the concerned discipline.

OR

Participation in Asian Games, World Championship with the Certificate Course in the concerned sports discipline.

OR

Participation in Olympics.

- 4. Fee: Rs.500/- (Rupees five hundred only) through Bank Draft in favor of 'Secretary, Sports Authority of India, New Delhi'. SC/ST and women candidates are exempted from payment of fee. Fee submitted through any other means will not be considered and such forms are liable to be summarily rejected.
- Selection procedure: The name of the candidates eligible to be called for the Skill / Physical Test and Interview will be uploaded on the SAI website and they will be called for the Skill / Physical Test.
- Salary: Consolidated salary of Rs.28,755/- per month (may be revised upwards).
- The engagement of coaches on contract basis will not confer on them any right for absorption or appointment on regular basis in SAI.
- No request for transfer to any particular place during the contract period would be entertained. The discretion to post the selected coaches and subsequent transfer will solely rest with the Competent Authority.
- 9. How to Apply: The application form duly filled in the prescribed format (available on SAI website (www.sportsauthorityofindia.nic.in) alongwith Demand Draft of Rs. 500/- (if applicable) may be sent to Dy. Director (Coaching), Sports Authority of India, Jawaharlal Nehru Stadium Complex (East Gate), Gate No.10, Lodhi Road, New Delhi-110003 through Speed Post/Registered/ordinary post/by hand. The discipline applied for should be mentioned on top of the envelope in capital letters.
- 10. Applications received after due date/through fax/e-mail or without bank draft of the said amount by the male applicants of the General and OBC category are liable to be summarily rejected. Sports Authority of India will not be responsible for any delay in the submission of form due to any reason.
