Minutes of the Departmental Project Approval Committee ("DPAC") Meeting Held on 04.09.2020

A Meeting of Departmental Project Approval Committee (DPAC) was conducted on 04.09.2020 at 03:15 PM via Video Conference under the chairmanship of Secretary (Sports).

The following members were present in the Meeting: -

Following decisions were taken:

- I.(a) JS & FA raised the issue of bringing clarity in respect of the role of DPAC-whether it is an Appraisal committee or approval committee, particularly in the context of the fact that all infrastructure proposals which are examined and approved by DPAC are subsequently dealt in file in the Ministry and after seeking IFD concurrence are got approved from Secretary (Sports) and MoS.
- (b) It was deliberated that as per Para 2.2.1 of the Khelo India Scheme guidelines (Published vide Gazette Notification dated 14.10.2017), The proposals under Khelo India will be examined/evaluated in the Mission Directorate- Sports Development. The projects will be appraised by a Project









Appraisal Committee (PAC) who will submit their recommendations before a Departmental Project Approval Committee (DPAC) headed by Secretary (Sports) for approval and monitoring of implementation. However, in para 2.2.3 of the Scheme guidelines DPAC has been mentioned as Departmental project Appraisal Committee. It was also pointed out that the proposals under those verticals of Khelo India Scheme which were handled directly by SAI were not examined/evaluated by the PAC.

- (c) Therefore, it was decided that proposals would be put up to MoS to seek approval for formation of two Appraisal Committee (PAC) one each in the Ministry and SAI for the verticals handled by them respectively. The DPAC would approve proposals which have been appraised by the two committees.
- (d) JS & FA (MYAS) raised the issue of bringing so many agendas in one meeting, which were circulated only a day before. The committee unanimously decided that henceforth DPAC meeting will be conducted on regular intervals and the Agenda Items would be shared with the Committee members well in advance.

II. The details of Agenda Items discussed and decision taken are as follows: -

Agenda Item No. 1: Decision on project proposals recommended by the Project Appraisal Committee (PAC) in its meeting held on 05.08.2020

The Committee decided to take this Agenda Item in the subsequent meeting. It was decided that Minutes of the *Project Appraisal Committee (PAC)* will be kept as supporting document with details of the project for examination and consideration of DPAC

Agenda Item No. 2: Release of funds for Implementation of Community Coaching Development vertical of Khelo India Scheme

The proposal was approved

Agenda Item No. 3: Release of funds for Implementation of Sports for Peace and Development vertical of Khelo India Scheme

Agenda Item No. 4: Release of funds for conduct of Ek Bharat Shreshtha Bharat Programme

The proposal was approved

Agenda Item No. 5: Proposals submitted by ITBP for development of adventure sports and winter games at Auli (Uttarakhand) and Leh (Ladakh)

It was decided that the proposal may undergo appraisal by the Project Appraisal Committee before it comes to DPAC.

Agenda Item No. 6: Khelo India E-Pathshala, level-based e- Learning online Platform for Athlete Coach and Education program (ACEP) for Grassroot athletes across multiple sports

The proposal for Khelo India e-Pathshala-level-based e- Learning online Platform for Athlete Coach and Education program (ACEP) for Grassroot athletes was approved by DPAC. The Committee advised on ensuring compliance to the GFR while taking forward the proposal.

It was recommended that instead of hiring the services of experts from the existing PMU by way of additional requirement, fresh RFP will be invited to hire Subject Matter Experts.

Agenda Item No. 7: Hiring of Consultant for Khelo India Winter Games Centre of Excellence – Gulmarg

It was decided that Jammu & Kashmir, UT will hire the Consultant for Khelo India Winter Games Centre of Excellence – Gulmarg. Committee approved the release of a budget of Rs. 50 lakhs for the project to the UT of Jammu and Kashmir from the appropriate vertical of Khelo India Scheme

Agenda Item NO.: 8 (c): Expenditure statement of Khelo India Youth Games, 2019 as per Annual Accounts.

The Committee noted that Budget Estimate for all the 3 Khelo India Games already stand approved previously as follows: -

- a. Budget of Khelo India Youth Games-2020, Guwahati was approved by DPAC vide agenda item No.3 of the Meeting held on 14.08.2020.
- Budget of Khelo India University Games-2020 was approved) on file on 10.12.2019
- c. Budget of Khelo India Youth Games-2019 was approved by DPAC vide Agenda Item No.10 of the Meeting held on 29.11.2018

Therefore, the committee decided that instead of placing the actual expenditure statement before DPAC, Utilization Certificate and Expenditure statement may be submitted to MYAS in terms of the sanction orders issued by the Ministry as per the usual practice followed by SAI.

Agenda Item No 9(a): Grant of Scholarships to the medal winners of Indigenous Games (04) for the F.Y. 2020-21.

The Committee was apprised that as per the decision taken in the DPAC meeting on 04.06.2019, the medal winners of the sub-junior and junior category in the National Championships are provided monthly OPAs (*The scheme provides scholarship in the nature of an OPA*) in four Indigeneous and traditional sports, namely, Mallakhamb, Kallarippayyattu, Gatka and Thang-Ta

The Committee approved to provide OPA to medal winners for the Financial Year 2020-21 on the similar lines as per last year.

Agenda Item No 9(b): Approval for the release of salary of coaches for the F.Y. 2020-21 and 2022 for the disciplines of Gatka and Thang-ta.

The proposal was approved.

Agenda Item No. 10: Release of grants as Block Grant under Khelo India scheme

This agenda was withdrawn and it was decided to put up this proposal separately.

Agenda Item No. 11: Engagement of Sports Science, Sports Medicine and Paramedical Staff for NCOEs.

It was pointed out that under the approved scheme of NCSSR, the expenditure on manpower would be made by the SAI from its Block Grant. However, since cadre review of SAI has not yet been done and posts for Sports Science not created, the committee approved the present proposal till 31st March, 2021. It is expected that cadre review will be completed by then.

The list of scientific personnel deployed in each centre and centre wise cost bifurcation is attached as **Annexure-I** was also brought to the notice of the committee.

Agenda Item No.12: Procurement of Sports Equipment for NCOEs and Khelo India Athletes.

The proposal was approved. Committee decided that funds may be released to National Sports Federations (NSFs) for procurement of Equipment, wherever required. When situation arise where NSF is not in a position to carry out the procurement., SAI may procure equipment for respective NSF.

Agenda Item No 13: Viability Gap Funding for Khelo India State Centre of Excellence (KISCE)

The Committee approved the following budget requirement w.r.t the 08 KISCE's in the States of Arunachal Pradesh, Manipur, Mizoram, Nagaland, Karnataka, Kerala, Telangana and Odisha in the DPAC meeting held on 04.06.2020:

The DPAC further approved the following:

- (i). DG SAI is authorized to:
 - a) Finalise the Memorandum of Understanding (MoU) to be signed with the respective KISCE for a period of 01 year initially, extendable by 04 years
 - b) Approve additional expenditure up to a maximum variation of 10% on total recurring expenditure
 - c) Internally modify the expenditure outgo within the overall approved budget within approved norms
 - d) Approve annual increment of up to 7% for recurring expenditure on account of inflation and salary increments
- (ii). The funding for recurring items for KISCE will be done from State Level Khelo India Centre (SLKIC) vertical, whereas funding for non-

recurring items and one-time grant to be met from Support to National/Regional/State Sports Academies vertical.

(iii) It was also recalled that as per approval vide agenda Item No. 1, Para-vii of the Minutes of the DPAC meeting held on 04.06.2020 – "The State academies/training Centres will hire personnel as per the norms of SAI for contractual engagement. SAI may also depute their coaches to such Centres. The State may get ex athlete or coaches on deputation. SAI will also issue SOP for hiring and will nominate one member in the selection committee. Actual hiring process and agreement. etc. will be carried out by KISCE". Therefore, as per this, funds will be released to State whenever required.

Since the infrastructure, available talent, Field of Play (FOP) and other facilities available at KISCE are at par with other regional level academies, henceforth all the notified KISCE's are deemed regional academy under Khelo India unless they are already accredited academies under vertical Khelo India talent Development.

Committee directed Sr. Director, Khelo India to circulate Draft MoU and it was decided that a presentation on the salient features of the MoU will be made in the next meeting.

Agenda Item No.17: Budget requirement for Celebration of 1st Anniversary of Fit India Movement and launch of Age Appropriate Fitness Protocols.

The proposal was approved.

Agenda Item No.18: Budget requirement of Rs.50 lakhs for the conduct of Fit India Freedom Run Campaign.

The proposal was approved with the decision that post facto is avoided in future.

Agenda Item No.19: Budget allocation and expenditure for the production of Fit India indigenous games freedom series videos

The proposal was approved with the decision that post facto is avoided in future.
