Confirmation of the Minutes of the 99th Meeting of the Finance Committee (FC) of Sports Authority of India (SAI) held on September 02, 2021

The Minutes of the 99th Meeting of Finance Committee of SAI were circulated vide Circular No. 6(28)/SAI/B&F/99thFC/2021-22 dated 6th September 2021.

7	Empanelment of Sponsorship Agencies for Khelo India.	Additional Secretary (Expenditure) sought clarification regarding exact scope of the agencies proposed to be empanelled. DG, SAI clarified that in line with the standard practice as being followed for established events, it is proposed that agencies can be empanelled for monetizing the items of Khelo India Games or other events of MYAS/SAI by way of obtaining sponsorship from Corporate for such items. There will be a competition among the empanelled agencies for getting the rights of a particular item for obtaining sponsorship. The competition will be in terms of guaranteed sponsorship committed by the agency. It has further been clarified that in case of series of events to be organized, then rights of organizing such events can also be handed over to agency for generating sponsorship based on commitment made by them regarding minimum revenue for SAI. <u>Revised registration fee for the Fit India Quiz and waiving off the registration fees for 2 lakh</u> <u>students from 1 lakh schools</u>

1. In order to propagate the message of Fit India among the school children and strengthen its presence in schools, a Fit India Quiz has been envisioned to involve school children across the country. The objective of the quiz is to provide a National platform for students to showcase their knowledge about fitness and sports. The quiz is the first National-Level Quiz for students which will give out total cash award of Rs 3.25 crore to schools and students. The funding for cash awards has been approved under Khelo India Scheme.

2. After preliminary market enquiry, the Fit India Mission has identified National Testing Agency (NTA) under Ministry of Education, Government of India as a suitable agency for the conduct of registration and preliminary round, simultaneously, across the country. Initially NTA has offered to conduct the exam at a registration fee of Rs. 225 per student and the fees would be directly remitted to NTA by schools at the time of registration. The proposal for engaging National Testing Agency (NTA) on nomination basis for the conduct of registration and preliminary round of Fit India Quiz, no cost to SAI, was concurred by the Finance Committee in its 98th meeting (copy of the minutes of FC meeting enclosed at *Annexure - A*) and the approval of Hon'ble Chairman Governing Body was obtained on file. Subsequently, the Fit India Quiz was launched on 01.09.2021. The registration process is open from 01.09.2021 to 30.09.2021.

3. As per the feedback received from various state governments, state wise nodal officers, schools, education boards and other stake holders, many of the schools and students were finding it difficult to make payment of Rs.225, specially the students studying in government schools. Consequently the number of students nominated by the schools during first one week was below par. In view of the above, efforts were made at higher level to reduce the registration fees charged by the NTA and after due deliberations NTA has offered the reduced fees of Rs. 50/- per students with the revised scope of work (copy of the letter from NTA is given at Annexure - B). As per the revised scope of work, for reducing the cost to bare minimum, Artificial Intelligence (AI) tools would be used in place of human proctors for monitoring the test real time and the test would be delivered only in the form of online mode on mobile phones. The committee constituted, re-examined the registration fee of Rs.225/- per student with respect to the revised offer by NTA with due diligence and recommended that price quoted by NTA is reasonable and justifiable (Annexure- C). During the various review meetings regarding the progress of the registration process, it was also felt that to popularize the Fit India Quiz and to ensure participation of schools and students at the desired level, registration fee to be waived off for the targeted number of students.

4. Accordingly, the revised approval on file was obtained from Hon'ble Minister / Chairman Governing Body, SAI for accepting the offer of NTA and further waiving off the registration fees for the targeted number of students i.e. 2 lakh students from 1 lakh schools by bearing the cost of registration fee by Fit India Mission. Financial implication for facilitating free registration is Rs. 1 Crore subject to actual number of students availing free registration facility and the source of funding will be Khelo India Scheme. The revised registration fees structure has been already implemented on 11.09.2021. Chairman, Finance Committee has concurred the proposal on file.

5. In view of the above, ratification of FC is solicited for the revised fee structure and waiving off the registration fees for the targeted number of students 2 lakh students with a financial implication of Rs.1 Crore.

Agenda Item No. 3

Approval of Annual Accounts and Financial Statement of Sports Authority of India (SAI) for the financial year 2020-21 (Provisional)

Finance Committee concurred with the proposal and recommended for the approval of the Governing Body. It was also directed to comply with the followings before placing the agenda before the Governing Body for approval:

- I. Annual Accounts and financial statements should be shown as "un-audited" stating that Accounts have been audited by Chartered Accountants firm.
- II. The audit report of CA firm should be annexed.
- III. It should be mentioned that the observations of SAR for FY 2018-19 has been incorporated.
- IV. The matter should be taken up with the construction agency for capitalization of assets created during the CWG-2010 and on completion of formalities regarding handing over and taking over of assets, the necessary corrections should be reflected in the Accounts.

Relaying of Non playing Area of Main arena at JLN Stadium, New Delhi

The Finance Committee has deferred the proposal in view of impending re-development Plan of JNS.

Agenda Item No. 5

Construction of 300 Bedded Hostel at SAI, NSEC Kolkata

The Finance Committee concurred with the proposal and recommended for the approval of the Governing Body.

Agenda Item No. 6

Selection of Transactional Advisor for conducting feasibility study for asset monetization for SAI Regional Centre Bengaluru and SAI Regional Centre Zirakpur

The Finance Committee concurred with the proposal and recommended for the approval of the Governing Body, however, word "Asset Monetisation "may be changed as it is not for sale of assets.

Agenda Item No. 7

Engaging National Testing Agency for the conduct of preliminary round Fit India Quiz for Schools across the country

The Finance Committee concurred with the proposal for engaging National Testing Agency (NTA) on nomination basis for the conduct of registration and preliminary round of Fit India quiz at no cost to SAI and recommended for the approval of the Governing Body subject to the following conditions:

- a) The per candidate application fee collected by NTA from schools shall be restricted to Rs. 225/- as per the proposal of NTA.
- b) SAI shall not collect any additional fee over and above Rs. 225/- per candidate.

Agenda Item No. 8

Signing of agreement between SAI and Foundation for Promotion of Sports and Games (FPSG) for a period of 4 years

During the discussion, JS&FA observed that the EOI floated in December, 2020 was not exactly in accordance with the decision of the Governing Body. Governing Body had directed that EOI detailing the scope of work, procedure, eligibility criteria, evaluation matrix etc. for selection of CSR partner may be floated and the EOI was to be one time with time limit whereas the present EOI has the validity of a year.

It was clarified that, earlier subsequent to the decision of GB under reference, EOI was floated but no concrete proposal was received. Subsequently, Glenmark Aquatic Foundation(GAF), IIS and few others shown interest in the partnership with SAI. Therefore, it was decided to float a fresh and simpler EOI enumerating specific areas of partnership with a validity period of one year to facilitate such partnership which will bring private sector expertise in the sports training.

The organisation whose proposal is under consideration is not a foundation of a corporate body and therefore the funding brought by them may not necessarily be of CSR. It was also submitted that the partners already approved i.e Glenmark Aquatic Foundation (GAF) and Inspire Institute of Sports (IIS), albeit being not-for-profit entities supported by the corporate, may not be categorised as strictly CSR partners. Moreover, the exact source of funding acquired by these organisations cannot be verified to be only of CSR origin.

The foundation under consideration has been established by two of the most prominent sportspersons of the country Sh. Prakash Padukone and Sh. Geet Sethi, Ex-Indian Hockey captain, Sh. Viren Rasquinha is the CEO of the foundation. The foundation is renowned for its programme named "Olympics Gold Quest" and is already supporting many top players of the country for more than 10 years.

In view of the above, it was decided that in order to make available the best possible facilities at SAI centres, there is a need to have a policy for considering such proposals of private entities received in response to EOI or otherwise. Therefore, it was decided that the proposal may be submitted before GB for taking policy guidance. Based on the decision of GB, the present proposal may be accordingly dealt with.

Supplementary Agenda Item No. 1

Waiver of interest amount on delayed payment for allotment of space at J N Stadium to Income Tax Department

The proposal was not agreed to.

Supplementary Agenda Item No.2 Creation of New Fields of Play at Various SAI Centres

The Finance Committee concurred with the proposal and recommended for the approval of the Governing Body. However, it was decided that the funding for all the three proposals is to be met from SAI Corpus Funds / Capital grant in view of approval obtained in 52^{nd} Governing Body Meeting regarding creation of infrastructure in NCOEs through Corpus Fund.

The meeting ended with a vote of thanks to the Chair.

We refer to letter dated 21.04.2021 communicating our offer to conduct the above Quiz in the Remote Proctored online mode and your letter dated 13.08.2021 accepting the same on the terms and conditions stated therein.

As you are aware, online registration of the candidates for the above test is in progress w.e.f 01.09.2021 onwards at <u>https://fitindia.nta.ac.in</u>. The registration window is scheduled to close on 30.9.2021.

It may be noted that in terms of Clause 2(i) of your letter dated 13.08.2021, the fee was agreed upon at Rs 225/- per candidate registered for the Quiz. Further in terms of Clause 2(vii) of your letter dated 13.08.2021, services covered included Remote Proctoring by Human Proctors.

In this connection, we inform you that it has been decided to reduce the fee to Rs 50/- per candidate registered covering bare minimum costs that NTA will have to incur for engaging an agency to deliver the test.

Accordingly, services extended will stand curtailed as follows:

"Services will cover delivery of the test in the online mode on mobile phones. The test will be proctored by AI tools only. However, the services will not cover Remote Proctoring by human Proctors."

The terms of engagement as mentioned in the letter/s mentioned above stand modified accordingly.

Other terms and conditions stated in the letter/s stated above remain the same.

Kindly send us your confirmation of the above arrangement at the earliest.



Minutes of the meeting of the committee constituted for Re-examining the per candidate registration offered by NTA for registration and conducting the Fit India Preliminary Round

The committee assembled for re-examining per candidate registration fee offered by NTA for registration and conducting the Fit India Preliminary Round held a meeting on 08.09.2021 at Fit India office, SAI Head Office, New Delhi.

2. The committee was appraised by the DD, FI that, as per the feedback received from various state governments, state wise nodal officers, schools, education boards and other stake holders, many of the schools and students were finding it difficult to make payment of Rs.225, specially the students studying in government schools. Consequently the number of students nominated by the schools during first one week was below par. In view of the above, efforts were made at higher level to reduce the registration fees charged by the NTA. Accordingly, after due deliberations NTA has offered the reduced fees of Rs. 50/- per students with the revised scope of work (copy of the letter from NTA is given at Annexure - B). NTA has conveyed that, they have decided to reduce the fee to Rs. 50/- per student registered covering bare minimum costs that NTA would have to incur for engaging an agency. As per revised scope of work, for reducing the cost to bare minimum, Artificial Intelligence (AI) tools would be used in place of human proctors for monitoring the test real time and the test would be delivered only in the form of online mode on mobile phones.

3. The committee considered the circumstances in which the revised scope of work and reduced registration fee structure received from NTA and also the fact that the registration process already started and only three weeks left for completion of the process.

4. The revised scope of work and registration fee have been diligently examined by the committee and the committee concluded that revised registration fee of Rs.50/- per student offered by NTA vide letter dated 08.09.2021 (enclosed as Annexure) is reasonable and justifiable and it would be beneficial for a large number of students who desire to participate in Fit India Quiz and it will also popularize the Fit India Movement among school children.

<u>Policy for Travel Arrangements of NCOE Athletes to their Home Town at the cost of Government</u>

The Governing Body in its 52nd meeting held on 13.03.2020 approved the restructuring of SAI sports promotional schemes as National Centre of Excellence (NCOE). {**Annexure A & B**}.

The National Centre of Excellence (NCOE) has been envisaged to provide facilities such as the state of art infrastructure, modern equipment and scientific back up along with specialized training, upgraded boarding and lodging facilities, sports kit, sports equipment, competition exposure, insurance, medical expenses etc. as per norms to cater needs of the talented athletes. The athletes in NCOEs are inducted from pan India through the Talent Identification and Development Committee (TIDC).

(A) **Provision for NCOE Athletes for their hometown visit:**

It is noted that, most of the athletes of the NCOEs come from moderate back ground and from different cities and villages across India. As such, it becomes very difficult for them to bear the expenses on their travel from their home to SAI NCOEs and vice-versa.

It is also submitted that, as of now, there is no provision for the NCOE athletes to travel to the Centres from their hometown and back, at the cost of government. However, as per NCOE norms athletes are entitled of Rs. 50,000/- for travel and competition exposure per athlete per year. This amount is being utilized for their competition visits only and not for their travel to home.

In view of the above, it is proposed that NCOE Athletes may be allowed to travel to their home town twice in a year at the cost to government. Expenditure on travel of the athletes will be met from competition and exposure head entitled to the athlete i.e. Rs. 50,000/- per annum and as such no additional expenditure is involved. However, preference will be given to competition visits of the athletes.

(B) Entitlement of athletes for the travel:

It is submitted that junior campers are entitled to travel to the camp at the cost of the Government air travel (Economy class) for the distance beyond 1200 km, else restricted to AC 3 Tier train fare. For senior campers the entitlement for air travel is for the journey beyond 500 km, else restricted to AC II Tier. Further, now junior camps have been merged into NCOEs and as such junior campers have become part of NCOEs.


Further, it is also submitted that in view of covid-19 situation, athletes were sent back to their home in urgency considering the surge in Covid-19 cases and called back in centres upon resumption of training, at cost to SAI. Taking the urgency of the situation into consideration, special travel arrangements were also made for the athletes allowing them to travel by air for the journey beyond 500 km and AC 3-Tier tickets were provided for the journey up to 500 km, with the approval of Governing Body. During this time also, a need was felt to have travel arrangements for athletes at cost to SAI for their travel from hometown to SAI centre and vice versa.

In view of the above, it is proposed that NCOE Athletes may be allowed for air Travel for their journey from their home town to SAI Centres and back for the distance beyond 500 KM (restricted to economy class), and rail fare (AC 3-Tier) to the athletes living within the 500 km radius of the centre.

Concurrence of the Finance Committee is solicited for:

(a) To allow NCOE athletes for to and fro journey from their hometown to NCOE twice in a year from their Competition and Exposure entitlement.

(b) For air travel to the athletes for their journey from their home town to SAI Centres and back for the distance beyond 500 KM (restricted to economy class), and rail fare (AC 3-Tier) to the athletes living within the 500 km radius of the centre.

Governing Body took note of the comments received through email from Shri B.V.P. Rao, one of the Members of the Governing Body, who could not attend the meeting.
