### Agenda Item No.3

### Implementation of 7th CPC for Teaching Faculty staff of SAI, LNCPE Trivandrum

The Lakshmibai National College of Physical Education (LNCPE), Thiruvananthapuram is a part of the academic wing of the Sports Authority of India (SAI). LNCPE is affiliated to University of Kerala with an aims to serve as a model institute for teacher's training by offering undergraduate and post-graduate/ research courses.

The service conditions and pay structures of the Teaching faculty of LNCPE, Trivandrum are governed by the UGC Regulations. The teachers of the institute are eligible for the revision of pay scale as per the guidelines of the Ministry of Finance and Regulations issued by the UGC. Ministry of Human Resource (MHRD) vide letter No. 1-7/2015-Ull (l) dated 2.11.2017 and subsequent corrigendum dated 8.11.2017 issued orders revising the pay scales of the teachers in Higher Education Institutions under the purview of UGC on the basis of recommendations of the pay review committee of UGC, following the revision of pay scales of Central Govt. employees.

As the MHRD has issued its orders for implementation of 7th CPC vide its order for the teaching faculty w.e.f 1.1.2016 along with Dearness allowance as issued by the GOI time to time and the arrears accrued may be paid accordingly. The implementation of the revised scales of pay of teaching faculty of LNCPE, Trivandrum an agenda was submitted in 94th Meeting of Finance Committee for concurrence. The FC, however, recommended to refer the matter to Department of Expenditure. The matter was taken up with the Ministry of Finance, Department of Expenditure through MYAS, who have conveyed the approval of Department of Expenditure vide letter No.28011/1/2018-SP-V dated 06.04.2022.

As per the guideline, 30% of arrear from 01.01.2016 to 30.06.2017 is to be met by SAI from SAI Internal Resources and 70% is to be met by MYAS (SAI Block Grant under Salary Head). For the rest of period, the entire amount/arrears will be paid from SAI Block Grant under Salary Head. Accordingly, a detailed calculation is given below:

In essence, the distribution of the arrear will be as follows:

- 1. SAI Internal Revenue Rs. 16.69 lakh
- 2. SAI Block Grant Rs. 416.20 lakh
- 3. From May, 2022 onwards, it will be paid from the regular salary head.

This has been vetted by the Finance Division of SAI and found in order.

Concurrence of Finance Committee is solicited for implementation of 7th CPC for the academic faculties of LNCPE with additional financial implications of Rs. 432.89 lakh up to 30th April 2022.

## Agenda Item No.4

#### Non utilization of funds released to SAI on 31.03.2022.

In the past, the Grant-in Aid to SAI was released on quarterly basis. However, for the last few years, the grant is released on monthly basis on receipt of request from SAI. In most cases, the grant is received almost in the end of the month whereas SAI is required to make payments to vendors for meeting the expenses on day to day basis. As on 31<sup>st</sup> March, 2022, SAI had incurred an expenditure or had committed liabilities under different heads and accordingly, MYAS was requested for release as per details given below:

Against our request for release of funds, MYAS released the payments as shown in column 6 above through PFMS late evening on 31.3.2022. Unfortunately, although all the 3 stages of transferring the funds to the beneficiaries/commercial bank were completed but transfer of funds could not take place as the system collapsed. On I<sup>st</sup> April, 2022 only an amount of Rs. <u>16.06</u> crore was shown as opening balance being the grant from the Khelo India division of MYAS for on going capital works. Whereas under all other heads zero balance was shown. Even this amount of Rs. <u>16.06</u> crore could not be transferred to the bank.

However, on 4<sup>th</sup> April, 2022 the following amount was shown as available balance in the PFMS Portal with notification "no sanction" for further release.

Since SAI had incurred this expenditure already or had liability, a request was made to the MYAS for taking up the matter with the Ministry of Finance to open the window of PFMS so that these funds could be utilized. The reply from the Ministry of Finance is awaited.

It is further submitted that as on date PFMS Portal is showing "ZERO" balance under all the aforesaid schemes.

The matter is submitted for kind information of Finance Committee.

### Approval of additional Funds for Broadcast of Khelo India University Games (KIUG), Karnataka 2021

Under the component 'Annual Sports Competition' (ASC) of Khelo India Scheme, 4 editions of Khelo India Games namely; (i) Khelo India School Games New Delhi, 2018 (ii) Khelo India Youth Games Maharashtra, 2019 (iii)Khelo India Youth Games Assam, 2020 (iv) Khelo India University Games Odisha, 2020 have been successfully conducted so far. The next edition of Khelo India Youth Games (KIYG) is scheduled to be held in the Host State of Haryana.

2. Further, the 2nd edition of Khelo India University Games – 2021 are planned to be conducted in Karnataka. Jain University, Bengaluru is the Host University for the Khelo India University Games Karnataka, 2021.

3. Pursuant to the budget approved in the 29<sup>th</sup> DPAC meeting held on 23.09.2021, an amount of Rs. 34.97 Cr. was approved towards the conduct of KIUG-2021, wherein a lumpsum amount of Rs. 3 Crores was approved for the production and broadcast of KIUG-2021. (DPAC agenda & minutes placed as Annexure 1A)

4. A letter was extended to Doordarshan (DD) for production and broadcast of KIUG-2021. Upon receiving the quotation from DD Sports regarding Telecast and Production charges a quote of Rs. 4,56,06,528/- has been received against the coverage and production charges of the said event. (Quotation placed at Annexure 1B).

Concurrence of finance committee is solicited for the following:

a) approving the fund of Rs 4,56,06,528/- towards the budget of KIUG-2021 for the component of Broadcast.



The agenda was deferred as it was decided to reconfirm from ITBP regarding requirement of funds.

#### Supplementary Agenda No. 4: Budget allocation of Rs. 1 crore for waiving off Fit India Quiz registration fees

The proposal was approved. It is clarified that in case more than two students participate from a school, SAI/MYAS will only bear the fee for two students only. In respect of more than two students, the fees will be paid by the school directly to NTA. FIT India Mission has assured maximum payment of Rs 1 Cr to the NTA for 2,00,000 students registered by one lac schools (max 2 students per each school). In the event of less number of students by the schools, the payment to NTA by SAI will be Rs 50 per students (that too max 2 students per each school).

#### <u>Supplementary Agenda No. 5: Approval of manpower for Talent Search and</u> <u>Development earlier approved by HPC</u>

This was approved by HPC formed as per existing Operational Guidelines. Once new guidelines are framed, comprehensive proposal as per the requirement to be assessed shall be moved by SAI.

#### <u>Supplementary Agenda No. 6: Extension of the human resource approved in</u> <u>DPAC meeting convened dated 15.09.2019 and 06.11.2020</u>

Approval is accorded till 31.12.2021. Once new guidelines are framed, comprehensive proposal as per the requirement to be assessed shall be moved by SAI.

#### Supplementary Agenda No. 7: Budget estimates, Financial assistance to host State/University and Roles and Responsibilities division of Khelo India University Games, 2021

The proposal was approved with a direction to inform DPAC about contribution of the State povernment.

The meeting ended with a vote of thanks to the chair.
