MINUTES OF THE 13<sup>TH</sup> (SPECIAL) MEETING OF THE GENERAL BODY OF SPORTS AUTHORITY OF INDIA (SAI) HELD ON 11<sup>th</sup> FEBRUARY, 2019 AT SHASTRI BHAWAN, NEW DELHI

The 13<sup>th</sup> (Special) Meeting of the General Body of Sports Authority of India (SAI) was held on 11.02.2019 at 4:00 PM at Shastri Bhawan under the Chairmanship of Col. (Retd.) Rajyavardhan Singh Rathore, Hon'ble Minister of State (I/C) for Youth Affairs & Sports.

At the outset, Member Secretary informed that this is a Special General Body of SAI convened with a specific agenda of change the name of 'Sports Authority of India' to 'Sports India'. Thereafter the Director General, SAI extended a formal welcome to the participants and informed that this special meeting is convened as it is mandatory to reconfirm the earlier approval of the General Body regarding the change of name of SAI. Thereafter with the permission of Chair, the Agenda Items were taken up:

Agenda Item No. 1: Confirmation of Minutes of the 12th Meeting of the General Body held on 04.01.2019.

The Minutes of the 11<sup>th</sup> Meeting of the General Body held on 04.01.2019 were confirmed.

Agenda Item No. 2: Change of Name of Sports Authority of India (SAI) to Sports India

Member Secretary informed that the proposal to change the name of 'Sports Authority of India' to 'Sports India' was approved in the 50<sup>th</sup> Governing Body Meeting held on 4<sup>th</sup> July, 2018 and subsequently by 12<sup>th</sup> General Body Meeting held on 04.01.2019. The proposal is again placed before the 13<sup>th</sup> General Body to reconfirm the change of name of 'Sports Authority of India' to 'Sports India' as it is mandated in

Societies Registration Act. It was informed to the meeting by Member Secretary that 3/5 of the total members present should reconfirm in favour of the proposal. Therefore, a written voting was done wherein all the Members present unanimously voted in favour of change the name of 'Sports Authority of India' to 'Sports India'. None of the Members present voted against the resolution. (Written Voting sheet is placed at **Annexure – II**). The total participants included 13 members and 04 proxies; all of who voted in favour of change of name (reconfirming the decision of the 12th General Body held on 4th January, 2019). The attendance of the participants which was recorded twice once at the start of the meeting and again at end of the meeting are placed at **Annexure I & III**.

After the discussion on Agenda Items it was also informed the General Body about the following initiatives taken for promotion of sports in the country:

- EOIs floated for inviting partnership under CSR for creation of Sports Infrastructure/Sports Development/Providing Diet/Sports Kit etc.
- A Mobile App on "Where to Play and How to Play" wherein the entire
  infrastructure available throughout the country will be mapped in phases and
  this will be a good educational tool about the basic parameters of how to play
  various sports. Besides, basic fitness of children will be mapped at a young
  age.
- Hon'ble Minister also apprised the gathering about the initiative of Community Coaches Development Programme being developed in collaboration with LNIPE, Gwalior. Under the programme, Coaches will be trained in different disciplines and a bank of Coaches will be created and this will be made available on a portal for various organisations.
