### Agenda Item No. 1: Khelo India University Games (KIUG) 2020

Under the component of "Annual Sports Competition" of Khelo India Scheme, there is a provision to organize sports competition for universities at the national level. Accordingly, the 1<sup>st</sup> edition of Khelo India University Games 2020 is proposed to be held from 22<sup>nd</sup> February 2020, at Bhubaneshwar, Odisha. Govt. of Odisha has given their consent to be the Host State.

The Salient features of University Games will be as under:

- a) The management of the event would be jointly done by the Ministry of Youth Affairs & Sports, Sports Authority of India, National Sports Federations (NSFs), All India University, the host University, i.e. KIIT University, Odisha and the State Government of Odisha.
- b) The Games will be called as Khelo India Association of Indian Universities Games, Bhubaneshwar 2020.

c) The following 15 (Fifteen) disciplines will be played in KIUG 2020:

- d) The technical conduct of the competition would be ensured by NSF.
- e) Although the nominations of the participants will come from various stakeholders, the participants need to be enrolled with university in order to represent them.

# Agenda Item No. 2: <u>Proposal from Cycling Federation of India (CFI) regarding resurfacing track area of Velodrome at LNIPE, Guwahati for Khelo India Youth Games (KIYG) 2020</u>

Pursuant to the approval accorded in the DPAC meeting dated 15.10.2019 for requesting the CFI for carrying out renovation of cycling velodrome at Guwahati and also in Balewadi Sports Complex, Pune. In response to the above request, a proposal has been received with the above subject matter with a tentative estimated cost of **Rs. 1,67,75,000/-** vide e-mail dated 6th Nov. 2019 from Cycling Federation of India (CFI).

Subsequently, in response to the above proposal, a letter dated 08.11.2019 has been issued to the Director, Cycling Federation of India granting permission to start the renovation of the Velodrome at LNIPE, Guwahati in smooth conduct of the KIYG 2020 (copy placed at 2-A.). The proposal for release of funds to CFI has already been processed with the approval of Secretary (Sports) being DPAC Chairman.

In view of the above, the above proposal from CFI is submitted for kind ratification of the Departmental Project Approval Committee.







Agenda Item No. 3: <u>Proposal for financial assistance of NADA for conducting testing awareness campaign during KIYG 2020</u>

In response to the letter No.KI/ASC/KIYG-III/NADA/2019-20 dated 24.10.2019 (copy placed at Annexure: 3-A) requesting requirements pertaining to NADA Operations during KIYG 2020, the proposal/requirements from NADA for Khelo India Youth Games 2020 are as follows:

a) Plans for Dope Control: It is proposed to collect 350 samples across 20 sports disciplines during above event.

### b) Estimate of Dope Testing:

1. No. of dope test planned for the event- 350 numbers

2. Cost of sample collection per sample USD 112.5@INR 70.69=INR 7953\*350 Nos. = INR 2,783,550/-

3. Travel Charges of Lead DCO/BCO/DCO=INR 10,00,000/-

- 4. Cost of dope sample analysis per sample by Anti Doping Laboratory, Doha, Qatar USD 120@70.69= INR 8483\*350nos=INR 2,969,050/-
- 5. Courier Charges for shipment of samples (350nos) from Guwahati to Doha, Qatar=INR 35,00,000/-

Total Cost= INR 1,02,52,600/- (One crore two lakhs fifty two thousand and six hundred only)

c) Overlays requirement of NADA for conducting the workshops to be provided by the State Government.

It may be noted that against the budget estimates of Rs. 91,07,500/- for the conduct of dope control programme during KIYG 2019, the DPAC had authorized DG, NADA to incur an expenditure up to Rs. 50 Lakhs for the same and any further increase in the expenditure may be borne by NADA itself.

Submitted for consideration and further directions of Departmental Project Approval Committee.







### Agenda Item No. 4: Budget of Time and Scoring Result (TSR) for KIYG 2020

It may be noted that for the 1<sup>st</sup> edition of the Games, as all NSFs were not in an equitable position to deal with the TSR vendors, it was decided that all TSR requirements should be fulfilled by floating a RFP for hiring of all TSR requirements for proper conduct of the Games. In this regard, the TSR was managed by OC-KISG at an estimated cost of Rs. 92,96,504/-.

Further for the second edition of the Games, it was noted that TSR is an extremely critical feature of the good marketing of the Games. The output generated from TSR on digital platform and on graphics has to be in synchronization and seamless integration with the broadcast signal which will be telecast on TV and digital platforms. In addition to the above, it was also noted that the Games Management System was to be developed to capture all the relevant information about the athletes, support staff and other participants. Additionally, information from result management system (schedule, fixture, venues, equipment) and logistics management (accommodation, transport, vendor management, inventory and distribution channel) are also required as part of Games Management System. In this regard, it was decided that the Host Broadcaster, i.e. M/s Star India Pvt. Ltd. should handle the complete end-to-end TSR management including the software, hardware and information about the participants to have a comprehensive solution.

However, it may be noted that in the previous two editions it was observed that TSR was not of the requisite quality and faced lots of problems. Thus, in the meeting of DPAC dated 14.08.2019, the committee entrusted the responsibility to hire required TSR, to the respective National Sports Federations (NSFs), for conducting the Khelo India Youth Games 2020.

As in KIYG 2020 there are 20 Sports Disciplines for which the required TSR system should be of International Standard so that the output generated from TSR on digital platform with graphics would get synchronized easily with the system of M/s Star Sports Pvt. Ltd., and as responsibility for the same is with the NSFs, NSFs were requested to submit the estimates for the hiring of vendor for TSR.

Against the received estimates, negotiations were held with the NSFs and it has been estimated that the overall cost of TSR for 20 Sports disciplines shall be **Rs 2,26,00,000/-(approximately)**.

In view of the above, the approval of the Departmental Project Approval Committee is hereby solicited for the following:

- (i) Total financial implication of TSR i.e., Rs 2,26,00,000/- to be released to concerned NSFs for Khelo India Youth Games (KIYG) 2020.
  - (ii) DG, SAI may be authorized to approve grants to different NSF within approved budget.







## Agenda Item No. 5: Additional requirement of funds due to increase in budget of Apparel because of inclusion of requirement of University Games.

The DPAC Committee in its meeting held on October 15, 2019 approved budget of Rs.10 Crores for the procurement of Sports Kits for **Khelo India Youth Games (KIYG) 2020**. Subsequently it was also decided to hold Khelo India University Games in Odisha. In order to take advantage of scale, the requirement of kitting for University Games was also included in the tender floated for apparel of KIYG.

In view of the above and revised quantities as per details given below, the total Budget for the procurement of Sports Kit would be Rs.20 Crores.:

- 1. For athletes, support staff, Media, Volunteers, members of Talent Identification committee, members and officials of KIYG 2020.
- 2. Athletes of NCOEs
- 3. Khelo India Athletes
- 4. For athletes, support staff, Media, Volunteers, members of Talent Identification committee, members and officials of Khelo India AIU Games 2020.

In view of the above, the approval of the Departmental Project Approval Committee is hereby solicited for the approval of the Budget of Rs 20 Crores excluding taxes for the procurement of Sports Kits for above-mentioned components.









# Agenda Item No. 6: Financial Implication for distribution of cash awards to medallists of Khelo India Youth Games (KIYG) 2020

The same matter was placed before the DPAC meeting held on 15/10/2019 and was deferred. With reference to Khelo India review meeting held on 13 Aug 2019, it is recorded in the proceeding that a suitable cash prize should be given to the winners at par with the winners of the international events. Award money as per MYAS Guidelines dated 30<sup>th</sup> May 2018 (placed as Annexure 6A), under the "Scheme of Special Awards to Medal Winners In International Sports Events and their Coaches" is as under:

- 1) Cash Prize for senior winning Athletes as per 1.2.1 of above guidelines, calculated as per award money earmarked for Commonwealth Championship (Held annually) (S. No. 12)
  - i. Gold @ 3.75 Lakhs.
  - ii. Silver @ 2.5 Lakhs.
  - iii. Bronze @ 1.25 Lakhs.
- 2) As per para 1.2.2, In case of Junior Level, the amount will be one third of the amount stated in Para 1.2.1 above rounded off to nearest tens of thousands of rupees
  - i. Gold @ 1.25 Lakhs
  - ii. Silver @ 83 Thousand
  - iii. Bronze @ 41 Thousand

### Agenda Item No. 7: Engagement of Human Resources in Khelo India.

The requirement and brief scope of work of the human resource in different verticals of Khelo India/SAI has been assessed and is mentioned below:

### Junior Consultant (Infra) & Consultant (Infra):

It may be noted that earlier WAPCOS was entrusted with the responsibility for all infrastructural projects of SAI. Further as approved in the DPAC meeting held on 25.09.2019, it has been decided that infrastructure projects sanctioned under Khelo India Scheme would be implemented through Sport Authority of India to ensure timely completion with standard quality; the works are to be executed by PMCs under the supervision and management of SAI.

In view of the above, more manpower is needed to perform the following tasks:

- a) All technical aspects of the Infrastructure Project both in and outside SAI and field offices.
- b) Responsibilities include technical as well as timely and cost-effective delivery of the project running in Khelo India and SAI.
- c) Supervising the stake holders in delivering the project covering all infrastructure elements with agreed cost, schedule and quality criteria.
- d) For the functional direction in the development, design as well as optimization.
- e) To enhance his or her knowledge and ability in the field of scientific analysis, engineering principle and project management.
- f) Support the development of Project Procedures and Policies for the execution of the various civil scopes of work in Khelo India and SAI.
- g) Ensuring that all opportunities and risks related to infrastructure project are properly evaluated and accounted for.
- h) Provide technical support and monitoring of execution issues and provide resolution to technical queries

### Young Professional (Legal) & Junior Consultant (legal):

- a) Draft Expression of Interest (EOI) and Request For Proposals (RFPs) for Procurement of Goods and Services for various divisions of SAI according to the GFRs, CVC Guidelines and Procurement Manual of Government of India;
- b) Handle all legal matters related to various divisions of SAI.
- c) Drafting of Contracts, Agreements, Memorandum of Understanding (MOUs) and all such legal documents pertaining to various verticals of Khelo India and other divisions of SAI.







# Junior Consultant (IT) and Computer Programmer (IT) for National Sports Repository System (NSRS):

The NSRS envisages to develop a comprehensive digital platform to link various verticals of Khelo India scheme. It will create the largest data bank of Athletes, coaches and various sports training centers/Khelo India academies. Each athlete, coach and sports training centre shall be identified with a unique ID No., which will serve as unique identifier for them. The admission of athletes in various programs of Khelo India schemes, identification & development of talent their performance, details of coaches & training centers/academies shall be available on portal. The first step will be the registration of athletes, coaches & training centers & subsequently the portal shall facilitate to use the scheme & various benefits to the relevant stakeholders. At present, SAI has basic structure of NSRS which is capable of registering the athletes and partial functionalities of Games Management System. It is required to develop in its complete form to cover all 12 verticals of Khelo India.

#### Job description:

- a. Technical requirement specifications and development/bug fixing of registration and verification of athletes, coaches, sports training centers.
- b. Requirement specifications and development of performance assessment module for all 20 sports disciplines of Khelo India.
- c. Technical requirement specification, bug fixing, talent deification and development of athletes under Khelo India scheme.
- d. Preparation of dashboards for various entities such as athletes, academies and national sports federations on NSRS portal.
- e. Technical specification, development, quality testing, monitoring and technical support for games management system during the Khelo India games.
- f. Maintenance and updation of Khelo India website.

In view of the above, the approval of DPAC is solicited for engagement of the abovementioned personnel initially for a period of 03 (Three) years and extendable for 03 (Three) years or coterminous with the scheme whichever is earlier. The salary can be revised after one year based on performance.







## Agenda Item No. 8: Requirement of funds for SAI training centres of SAI other than NCOE.

There are 69 SAI training centres other than those co-located with NCOE. The total strength of the athletes in these centres is estimated at 6341. Out of these 69 centres, 18 centres were notified as State Level Khelo India Centres vide DPAC approval dated 07.03.2019 and 28 centres vide DPAC approval dated 03.06.2019.

i) The total annual expenditure with respect to these 46 SLKICs amounts to Rs. 102.48 crores, including recurring expenditure, maintenance and salary expenditure as depicted below:

The expenditure per quarter amounts to Rs.25.62 crores, which has been released till 3rd Quarter in respect of these 46 STCs.

ii) The remaining 23 STCs of SAI (list at Annexure II) are currently being budgeted out of SAI block grant. The proposed sanctioned strength in these 23 centres is 1205 residential and 284 non-residential athletes totaling to 1489 athletes. The annual expenditure w.r.t these 23 centres amounts to Rs. 41.78 crores as depicted below:

As these centres adhere to the norms of State Level Khelo India Centre, it is proposed that the remaining 23 non-regional training centres of SAI may also be funded under Khelo India. The revised annual expenditure, thereof, of around Rs.144.26 cr may be approved against all 69 STCs.

### Approval of DPAC is sought for:

All 69 STCs to be funded under Khelo India with the revised annual expenditure amounting to Rs. 144.26 crores, out of which funds amounting to Rs. 43.03 crores may be approved for Financial Year 2019-20.







Agenda Item No. 9: Approval of sanction for the conduct of State and District Level Competition by the NSF under the Khelo India Scheme 'Promotion of Sports among Divyang Persons'

'Promotion of Sports among persons with Disabilities' is a vertical of Khelo India notified by MYAS on 1<sup>st</sup> Nov 2018. An ACTC Meeting was held under the Chairmanship of Secretary Sports on 9<sup>th</sup> Aug 2019. SOB presented their requirement for National, State and District Championships.

The National Federations were advised to submit their proposal for organizing the State Games, District Games and Community Coach Training Programme. PCI, SOB and AISCD were advised to project their requirement for the National, State and District Competitions. A meeting was held with the representatives of SOB, AISCD and PCI.

Proposals which were received from SOB, PCI and AISCD are as follows:

1. AISCD: (22 States, 03 UTs, 238 Districts): Rs. 4,95,14,24,000

2. PCI: (12 States, 01 UT, 419 Districts): Rs. 15,83,09,550

3. SOB: (28 States, 05 UTS, 722 Districts): Rs. 07,01,28,000

TOTAL = Rs. 5,17,98,61,550/-

(Rupees Five Hundred Seventeen Crore Ninety-Eight Lakh Sixty-One Thousand Five Hundred and Fifty Only)

The proposals were re-examined multiple times while the NSFs were encouraged to be realistic in their proposals. The final outcome of deliberations which is proposed below has been drawn in consultation with SOB and AISCD only since PCI has been derecognized by MYAS. The activities proposed below along with financials cover the entire nation with special emphasis on North Eastern States and UTs with adequate opportunity for athletes who are covered under the category of **Divyang.** 

The proposal has been drafted in a manner that it enables conduct of the competitions in joint collaboration between NSF creating an environment of sports festival. This will ensure dissemination of information on the scheme of Khelo India throughout the nation and also be a catalyst in encouraging youth for participating in sports which shall help them improve the quality of their lives.



As requested, following information is provided:

**Plan for Dope Control:** It is proposed to collect 350 nos of samples across 20 sports disciplines during above event.

Office space requirements: Since, the Games are organized at outside Delhi and due to large number of participation of Athletes in above multi sports event. It is proposed setup Doping Control Command Centre (DCCC) (700 sq ft approx) at main stadium, Guwahati with a minimum requirement for DCCC as follows:

- 1. Two (2) Computers with internet facility
- 2. Deep freezer for temporary storage.
- 3. One (1) Almirah with lock & key
- 4. Four (4) tables & five (5) –six (6) chairs
- 5. Other Stationary items.

c) Accommodation and catering requirements for the personal: It is also proposed to depute NADA officials along with DCOs/BCO/Chaperone during above Games and we may request the Organizing Committee to arrange the Boarding/Lodging during the above Games, at single point of time 20 nos (approx) rooms are required in Guwahati.

In addition to above, anti doping education cum awareness program is planned for the participating athletes and staff during the games. The logistic requirements and overlays will be requested post site visit of the venues.






### DOPING CONTROL STATION

For each Doping Control Station, at least two separate rooms need to be identified close to the competition venue. In one of the rooms of the Doping Control Station, the following facilities may be made available:-

- (i) Refrigerator (with lock and key)-1,
- (ii) Table-5,
- (iii) Chairs-8-10 nos,
- (iv) Dustbin-2,
- (v) Clip Boards-4
- (vi) Scissors- 2
- (vii) Tissue paper- 5 Rolls
- (viii) Liquid hand soap
- (ix) Hand Towels
- (x) Needle destroyer
- (xi) Disposable system for bio medical waste
- (xii) The other room should be equipped with at least 8-10 chairs for athletes/sportspersons as waiting room.
- (xiii) Toilets for athletes should be in close vicinity to the Doping Control Station for urine sample collection of athletes.
- (xiv) Ten volunteers and one Attendant may be identified for the Doping Control Station to provide necessary assistance to the DCOs.
- (xv) Sealed mineral water bottles (50 nos) is required to be arranged for each Doping Control Station every day so that the same may be provided to the athletes, if required by them before giving their urine samples.

# SCHEME OF SPECIAL AWARDS TO MEDAL WINNERS IN INTERNATIONAL SPORTS EVENTS AND THEIR COACHES (amended as on 30th May 2018)

1.0 The special awards were introduced in the year 1986. Objective of the Special Awards is to incentivize the achievements of outstanding sportspersons, encourage and motivate them for higher achievements and to act as inspiring role models for attracting the younger generation to take up sports.

### 1.1 ELIGIBLE SPORTS DISCIPLINES

The Awards will be given in the following disciplines:

- (i) Sports disciplines in Olympics/Asian Games/Commonwealth Games.
- (ii) Chess.

### 1.2 AMOUNT OF SPECIAL AWARDS

### 1.2.1 Individual Events at Senior Level:

- 1.2.2 Individual Events of Junior Level for sports competitions stated in Para 1.2.1 above: In case of Junior Level, the amount will be one third of the amount stated in para 1.2.1 above rounded off to nearest tens of thousand of Rupees.
- 1.2.3 Individual Events of Sub Junior Level for sports competitions stated in Para 1.2.1 above: In case of Sub Junior Level, the amount will be one sixth of the amount stated in para 1.2.1. above rounded off to nearest tens of thousand of Rupees.
- 1.2.4 **Team Events:** These are the events where competition is among the teams. Each team has more than one person as member.
- (i) The amount of Special Award in respect of team events for sports disciplines stated in Para 1.2.1 above will be determined as under:

Strength of 'Team' on the ground: Number of times, the Award amount mentioned in para 1.2.1 above for the corresponding event, medal, level and category of participation.

(a) A team of two persons : 1 ½ times
(b) A team of 3 or 4 persons : 2 times
(c) A team of 5 to 10 persons : 3 times
(d) A team of more than 10 persons : 5 times

- (ii) The actual prize money determined as above will be shared equally among the team members. However, no member of team would get less than 50% of the award amount mentioned in para 1.2.1 for the corresponding individual event, medal, level and category of participation.
- (iii) Chess Olympiad, held biennially, where teams participate, will be treated at par with World Championships held biennially and amount of award money payable to members of the team will be calculated as per formula given in para 1.2.4 (i) and (ii) above.
- 1.2.5 **CHESS**: In Chess apart from awarding medals or positions in Championships, certain titles are also awarded for creditable performances in standard events, which is something unique in Chess. Therefore, Special Awards will be available not only for winning the international championships, but also for winning the title given by FIDE (International Chess Federation) provided the concerned sportsperson wins it before the age of twenty years.

(iii) International Women Master (IWM): Rs. 1.5 lakh

The women chess players will be eligible for the Special Award either for the title of IWM or IM but not both.

Title of 'International Grand Master' will be given to both men chess players and women chess players.

#### INCENTIVE TO INDIAN COACHES 2.0

- The amount of the cash award payable to the coaches will be as under: 2.1
- (i) In case of Individual events, award money to be given to the set of coaches will be 50% of the award money given as per this scheme to the sportspersons whom the set of coaches had coached.
- (ii) In case of team events, award money given to the set of coaches of the medal winning team will be the same as to the set of coaches in para 2.1 (i) above for similar medal. The set of coaches could comprise of 1 or more coaches. In case, the set contains more than one coach, the said award money will be distributed among all the coaches in the set, equally.
- The amount of cash award payable to coaches of medal winners in individual events will be distributed among the following types of coaches in the ratio mentioned against each category:
  - (i) Coach at grass root level who initially spotted the talent and groomed: 30% of the amount payable to the coaches
  - (ii) Coach at the developmental level who further groomed and nurtured the medal winning sportspersons which would also include personal coach: 30% of the amount payable to the coaches
  - (iii) Coach(es) at the elite level who have been part of the coaching camps or imparted training to the medal winner for at least 180 days in the preceding two year period before the event: 40% of the amount payable to coach(es)
- Names for coach at grassroot level and coach at the developmental level will be as 2.3 recommended by the medal winning sportsperson. However, spouse, father, mother, brother and sister of the sportspersons will not be eligible for cash award in these cases.

()-

- 2.4 For the Coach(es) at the elite level who have been part of the coaching camps or imparted training to the medal winner for at least 180 days in the preceding two year period before the event, the set of coaches could comprise of 1 or more coaches. In case, the set contains more than one coach, the said award money will be distributed among all the coaches in the set, equally.
- 2.5 The Special Awards for the Coach(es) at the elite level will be given regardless of whether a coach is a Chief coach or Assistant Coach subject to the condition that the coach should have been associated with the training of the athlete/team on a regular basis for at least a minimum period of 180 days, i.e., each coach in the set of coaches should have been associated with the medal winning sportsperson / team for at least 180 days on a regular basis.
- 2.6 Sports Authority of India (SAI) will devise a mechanism and build up a data base about the grassroot coaches, developmental coaches including personal coaches for verifying the recommendations made by the medal winning sportsperson for giving cash award.
- 2.7 If in an event, more than one medal is won by different individual sportspersons trained by the same coach, the coach will get the cash award only for the highest medal.
- 2.8 If there is any doubt/dispute about the names of coaches recommended for cash award, the Ministry of Youth Affairs & Sports will have the final say in the matter after due deliberations.
- 3.0 Enhancement in amount of award money: The amount of award money, as mentioned in para 1 above, may be increased once in four years, by the Minister-in-charge of Youth Affairs & Sports on the recommendations of a Committee chaired by Secretary (Sports), which will, inter alia, include Financial Adviser of the Ministry.

### 4.0 Application for the award:

Annexure-I. Application form for cash awards should be sent under the signature of President or Secretary General of the NSF. Bank details of sportspersons/coaches recommended for cash award should be given as per mandate form at Annexure-II. The attested Xerox copies of the certificate of winning medals given by the corresponding International sports body should also be enclosed with the said intimation. Ministry will forward the applications for cash award to Sports Authority of India for verification within 15 days of receipt of applications. SAI will verify the same and forward it to Ministry within 15 days of receipt of applications from the Ministry.



- 4.2 NSFs will be required to send separate applications in respect of sportspersons winning medals in individual events.
- 4.3 NSFs will be required to send only one application in respect of team events for all members of the team.
- 4.4 In case, NSF for any sporting discipline is not recognized / suspended by the Ministry, the sportsperson will apply directly to Ministry.
- 4.5 The Ministry of Youth Affairs and Sports, Government of India reserves the right to give the Special Award even if names of sportspersons have not been recommended by the concerned NSF, if the Ministry is satisfied about the eligibility of the events and the medals won by such sportspersons.

#### 5. General

- (i) The international sports competitions mentioned in para 1.2 above should have been conducted by the international sports body recognized by International Olympic Committee (IOC), International Paralympic Committee (IPC), Olympic Council of Asia (OCA), World Chess Federation (FIDE), International Sports Committee for the Deaf (ICSD), International Blind Sports Federation (IBSA), Special Olympics International.
- (ii) The Olympics, Paralympics, Asian Games, Para-Asian Games and Commonwealth Games are fairly well defined sports events. However, there may be some ambiguity in determining as to which official World/Asian/Commonwealth championship should be eligible for the Special Awards, as there may be many kinds of tournaments, cups or championships all organized officially but only one and the best of them may be listed as the official World/Asian/Commonwealth Championships in each eligible discipline for the purpose of these awards. The Government of India shall have the right to decide as to which event will be eligible for the special award.
- (iii) World Cups/Championships organized more than once a year will not be considered for cash Award.
- (iv) With the approval of the Minister-in-charge of Youth Affairs & Sports, suitable cash awards can be announced in very deserving cases for events not covered under the scheme.

#### 6. Relaxation clause:

6.1 The Ministry reserves the right to add, relax, amend, alter or revise the clauses/sections/provisions of the instant Scheme with due approval of the Minister-in-charge of Youth Affairs & Sports. In case of any change/alteration in the financial parameters of the Scheme, the same will be effected with due approval of the Integrated Finance Division.


