Minutes of the Meeting of the Departmental Project Approval Committee ("DPAC") held on 06.11.2020

A Meeting of Departmental Project Approval Committee (DPAC) of the Khelo India Scheme was conducted on 06.11.2020 at 11:00 AM under the chairmanship of Secretary (Sports) in his chamber.

The list of members who attended the meeting is enclosed at 'Annexure-I'.

Following Decisions were taken in the meeting: -

Agenda Item No. 1:Funds disbursement to NSFs/NCOEs for Khelo India e-Pathshala.

Senior Director, Khelo India clarified that the following was approved by DPACin its meeting dated 04.09.2020: -

- a. Rs. 1,78,92,576/- were approved for setting up of a Project Management Unit (PMU) for Khelo India e- pathshala for 18 months.
- b. An indicative amount of Rs. 60 Lakhs per discipline was approved for 3 Sports Discipline to be largely utilised for Content Creation, Hiring of manpower and running of programme.

In view of the discussion in DPAC, since the federation have now been recognized, funds can be released to them under (b) above.

Agenda Item No. 02: Conduct of various promotional activities for Fit India out of the obligations of Media Partner as per License Agreement between SAI and STAR India (Media Partner).

The Committee took note of the factthat Fit India is part of Khelo India Scheme and is an initiative of Government of India. Therefore, the proposal to conduct the Fit India Quiz out of obligations of Media Partner is approved in principle.

Agenda Item No. 03: Budget allocation for the production of 3rd Series of Fit India indigenous games videos
