Agenda Item – 3: Additional Funds to Host States Assam and Mizoram for Khelo India University Games 2023

The proposal was ratified with an observation that on receipt of funds from the Ministry of Development of North Eastern Region (DoNER Ministry) the same may be adjusted against expenses incurred under Khelo India and accordingly utilization certificate to be provided. The funds received would be used in the current financial year.

Agenda Item - 5: Extension of tenure of Khelo India Centres (KICs) and Khelo India State Centre of Excellence (KISCE)

It was observed that the scheme started in the year 2020 and it was expected at that time the Past Champion Athletes engaged as coach in KICs would get enough experience and recognition to be able to run the centre without any further recurring grant from the government in the time span of four years. however subsequently due to onset of covid pandemic there was a delay in operationalizing the Khelo India Centres and State Centres of Excellence and also hiring of Past Champion Athletes. Hence, DPAC decided to extend the tenure upto the scheme period i.e. 2025-26.
