Engagement of National Testing Agency (NTA) for the conduct of Preliminary Round of Fit India Ouiz 2023

Background

In order to propagate the message of Fit India among the school children and strengthen its presence in schools, Fit India Quiz has been envisioned to involve school children across the country. The quiz is a National-Level Quiz for students which will give out total cash award of Rs. 3.25 crore to schools and students. In the previous two editions of Fit India Quiz, 98,280 students from 30,204 schools participated and showcased their knowledge in fitness and sports. In both the editions, National Testing Agency (NTA) was selected to conduct the preliminary round. To cater the requirement of online preliminary round, a web portal was developed by the NTA for registration. Further, NTA has also developed a mobile application for conducting multi-lingual preliminary rounds of the Quiz.

Fit India Quiz has become a popular mechanism to align the kids across the country to join the mission of fitness and adopt the fit lifestyle. In this edition, the four rounds of the quiz will include School Round, Preliminary Round, State Round and National Round. The quiz structure and prize structure in the Fit India Quiz 2023 will be in the similar lines of the second edition of the Fit India Quiz 2022.

2. Proposal

- 2.1 In order to ensure maximum participation, the registration of candidates and preliminary rounds have been conceptualized through online mode on a suitable platform and taking the test by individual candidate using mobile phone from a convenient place on a sophisticated mobile based platform with adequate security features to ensure fair and transparent conduct of exam. Based on the experience of successful execution of the second edition of Fit India Quiz, Fit India Mission is considering National Testing Agency under Ministry of Education, Government of India as a suitable agency for the conduct of registration and preliminary round, simultaneously, across the country. NTA has been formed specifically to conduct entrance exams for admissions to Institutions of Higher Education such as IITs, AIIMS etc. and it has the capability in delivering exam in more than 13 languages. National Testing Agency has already developed a web portal and a mobile application exclusively for Fit India Quiz.
- 2.2 After multiple rounds of discussion with NTA and based on the experience of conducting the Preliminary round for previous two editions of Fit India Quiz, it is proposed to engage NTA for the third edition of Fit India Quiz. Accordingly, NTA has offered the revised fee structure for conducting the preliminary test on basis of evaluating the cost incurred by NTA in the first and second editions.
- 2.3 In the previous edition, NTA had charged Rs.70/- per participant (Rs. 50/- per participant collected from the school + Rs. 20/- collected from Fit India Mission), if the total number of participants registered are 1,00,000 or above. However, under the new fee structure, NTA has proposed to collect Rs.100/- per participant directly from the interested students. However, in order to maximize the registration of schools and encourage participation of students in the quiz, the 41st DPAC in its meeting held on 06.10.2023 had decided to exempt the students from government schools (both central and state) from the requirement of paying

fees. The minutes of the 41st DPAC are placed as <u>Annexure - A.</u> As per the technical design of the NTA website the schools are required to register, nominate the students and pay the fees for completing the registration process. Accordingly, NTA will refund the registration fee collected from government schools after the conduct of the Preliminary Round. The same will be reimbursed to NTA by the Fit India Mission.

- 2.4 In this regard, it is submitted that the 1st edition of the Fit India Quiz held in 2021 had the provision of free registration facility limited to two students per school. Subsequently, SAI Governing Body also approved the proposal in its 55th meeting. In case of nomination of more than two candidates by the school, they were required to make a payment of Rs 50/- per student for candidates over and above two candidates. This initiative had led to a registration of 69,303 schools and 1.8 lakh students.
- 2.5 As per the data submitted by the National Testing Agency (NTA), the Fit India Quiz 2023 has witnessed a total registration of 63,167 schools out of which 52,786 schools are government schools. The details are as mentioned below:

However, the actual refund amount will be quantified after the completion of Preliminary Round of Fit India Quiz 2023 in consultation with NTA. For this purpose, as directed by the 41^{st} DPAC, the approval of Hon'ble Chairman of Governing Body, SAI was obtained on file dated 17.10.2023 for the refund of registration fees of all government schools which is placed as Annexure – B.

3 Hiring of NTA for registration and preliminary round of Fit India Quiz 2023.

As per GFR 194, Single Source Selection/Consultancy by nomination- the selection by direct negotiation/nomination, on the lines of Single Tender mode of procurement of goods, is considered appropriate only under exceptional circumstance such as:

- (i) Tasks that represent a natural continuation of previous work carried out by the firm;
- (ii) In case of an emergency situation, situations arising after natural disasters, situations where timely completion of the assignment is of utmost importance; and

- (iii) Situations where execution of the assignment may involve use of proprietary techniques or only one consultant has requisite expertise.
- (iv) Under some special circumstances, it may become necessary to select a particular consultant where adequate justification is available for such single-source selection in the context of the overall interest of the Ministry or Department. Full justification for single source selection should be recorded in the file and approval of the competent authority obtained before resorting to such single-source selection.

It shall ensure fairness and equity and shall have a procedure in place to ensure that the prices are reasonable and consistent with market rates for tasks of a similar nature; and the required consultancy services are not split into smaller sized procurement.

As specified in para 2.1 above, NTA had developed the web portal and mobile application exclusively for the Fit India Quiz during their engagement in Fit India Quiz 2021 and 2022. The preliminary rounds of previous editions of the quiz were also held in 13 languages. Hence, the GFR rule 194 (i) and (iii) mentioned in para 2.7 above can be applied and invoked for selection of National Testing Agency (NTA) for the conduct of registration and preliminary round of Fit India Quiz 2023 on nomination basis.

2.	Action Taken report on 40th meeting of DPAC held on 23.08.2023	Confirmed. With respect to Item No. 3, DPAC observed the following: i. It was observed that there has been less registration so far for the Fit India Quiz, hence it was decided that government schools (both Central and State) may be exempted from the requirement of paying registration fees to encourage wider participation and more registration. Approval of chalrman may be sought at once on this recommendation.
3.	Engagement of 100 Professionals for implementation & monitoring of Khelo India scheme	DPAC approved Rs. 10 crore for a maximum of 100 resources for a period upto 31.03.2026. The modalities and process of engaging 100 resources may be finalized at the level of DG SAI.

Subject-Refund of Registration fees for all Government Schools for Fit India Quiz 2023

Fit India Quiz was launched in 2021 as a part of commemorating 'Azadi Ka Amrit Mohotsav', it was envisaged to propagate the message of Fit India among the school children and strengthen its presence in schools, a Fit India Quiz has been envisioned to involve school children across the country. Fit India Quiz (FIQ) is dedicated to the school students where students with interest in sports and fitness can participate and compete at state and national level. It has become a popular mechanism to align the kids across the country to join the mission of fitness and adopt the fit lifestyle. Fit India Quiz comprises of preliminary rounds, state level rounds and national rounds, thus making it one of the most comprehensive and flagship quiz programs on fitness and sports in the country

Fit India Quiz 2021 & 2022: In the first edition of Fit India Quiz, 36,299 students from 13,502 school had participated and showcased their knowledge in fitness and sports. In the subsequent 2nd edition, launched on 29 August 2022, a total of 61,981 students from 16,702 schools across 702 districts had participated. The National Testing Agency (NTA), known for conducting JEE and NEET, was engaged for registration and conduct of Preliminary rounds where registration fee of Rs 50/- per students was applicable and was paid by the registering schools. SAI-LNCPE was engaged for developing the question bank for the preliminary rounds. Provisions were made to have preliminary rounds in 13 languages- English, Hindi, and 11 other vernacular languages.

In the Fit India Quiz 2022, after the preliminary rounds, 348 schools from 36 states/UT were selected for State/UT web rounds from 215 districts. 36 State/UT champions were identified after 120 web-rounds. 12 government schools among the State/UT champions. The National Finals of the Fit India Quiz 2022 was held in Mumbai in July 2023. The telecast of 13 episodes of National finals have begun from 12th August 2023, 8 AM on Star Sports and Hotstar (every Saturday and Sunday) and has garnered a total viewership of 1.4 million.

3. The Fit India Quiz 2023 in its \mathfrak{G}^d edition, was launched on $2\mathfrak{G}^h$ August 2023 on the occasion of National Sports Day and with this edition it is envisaged to reach out to higher number of schools, with greater participation from every state and district of the country.

Structure of Fit India Quiz:

The Fit India Quiz is primed to be the first of its kind nation-wide quiz on sports and fitness for school children with the total cash prize worth Rs 3.25 Crore. The quiz will have representation from every State/UT in the country and will be a mix of online, physical and broadcast rounds. The quiz format has been designed in an inclusive manner where school students from across the country will get an opportunity to test their sport and fitness knowledge against their peers. The quiz will start with a nation-wide registration followed by preliminary round, State-wise round and finally a Broadcast round which will be telecast on national television.

- 4.1 The quiz will have three phases-
- Phase 1 will start with a nation-wide registration by schools followed by selection of teams for the state/UT rounds through a preliminary round
- Phase 2 will comprise of state/UT rounds where the schools selected in the state/UT merit list shall compete
 for the state/UT championship
- Phase 3 will have a broadcast round which will be aired nationwide on popular National Television Network and OTT platforms. In these rounds, 36 state/UT champions to compete for National Championship.

The details of the three phases of the quiz are placed at Annexure 1.

- 5. The 40th Departmental Project Approval Committee (DPAC) in its meeting held on 23.08.2023 has approved the budget of Rs 6.69Cr for the conduct of the Fit India Quiz 2023 The details of the approved expenditure for Fit India Quiz 2023 are placed at Annexure 2 (Agenda, Minutes of 40th DPAC)
- 6. Accordingly, the registration for Fit India Quiz 2023 started from 04.09.2023 to 05.10.2023 with a registration fee of Rs 100/- per student being charged by the National Testing Agency (NTA). However, in view of the poor registration of the schools, the last date of registration for the quiz was extended till 31.10.2023. A circular to this effect was issued by the Fit India Mission which is placed as Annexure 3.
- 7. Further, the 41st DPAC in its meeting held on 06.10.2023 observed that there has been less registration so far for the Fit India Quiz, hence it was decided that the government schools (both Central and State) may be exempted from the requirement of paying registration fees to encourage wider participation and more registration of schools. The DPAC has also recommended that the

approval of Chalrman for the above may also be sought. The agenda and minutes are placed as Annexure 4. (Agenda, Minutes of 41st DPAC)

- 8 . In this regard, it is submitted that the 1st edition of the Fit India Quiz held in 2021 had the provision of free registration facility limited to 2 students per school at the per-student cost of Rs 50/-. Subsequently, SAI Governing Body also approved the proposal in its 55th meeting. For schools nominating more than two candidates, a payment of Rs 50/- per student was made by schools for candidates over and above two candidates. This initiative had led to a registration of 69,303 schools and 1.8 lakh students.
- 9. In view of the above, it is pertinent to mention the registration data of the schools during the previous edition of Fit India Quiz i.e Fit India Quiz 2022. As per the data submitted by the National Testing Agency (NTA), the Fit India Quiz 2022 had witnessed a total registration of 42,490 schools out of which 17,990 schools were government schools. The details are as mentioned below:

Capacity Building of Past Champion Athletes (PCAs) hired in Khelo India Centres (KICs)

The Khelo India Centre (KIC) component under the Khelo India Scheme has twin objectives:

- i. Providing sports training/coaching to willing children.
- ii. Providing a sustainable source of livelihood outside the government set-up to past champion athletes.

KICs are expected to be the nurseries for sports talent, the progression of athletes to SAI Training Centres (STCs), National Centres of Excellence (NCOEs), Khelo India State Centres of Excellence (KISCE), states managed academies, private academies, participation of athletes in Khelo India Youth Games and other similar parameters would be utilized to analyst the performance of KICs. It is pertinent to conduct capacity-building exercises to empower the Past Champion Athletes to achieve this. The capacity-building exercise would help PCAs inculcate correct techniques at the grassroot level.

SAI Netaji Subhash National Institute of Sports (NSNIS), Patiala is the academic wing of SAI which was established in the year 1961, is not only training the athletes but also providing different courses on sports coaching, sports science and performance analysis to coaches and sports scientist. The institute has also started the Three Weeks Refresher as well as Six Weeks Certificate Courses in different sporting disciplines in order to impart training to the coaches across the country.

As of now, around 819 PCAs have been hired across the country. Of 819 hired PCAs, 327 PCAs need refresher course, which is approximately 40 % of hired PCAs. Assuming this ratio, the following budget is proposed for the capacity building of 1317 PCAs (1000 KICs, including new and converted KICs and 250 KICs which are yet to be notified):

Overview of Fit India Quiz-

Fit India Quiz launched in 2021 as a part of commemorating the 'Azadi Ka Amrit Mohotsav', was envisaged to propagate the message of Fit India among the school children and strengthen its presence in schools. The objective of the quiz is to provide a national platform for students to showcase their knowledge about fitness and sports, also endeavors in its philosophy to create awareness among students about India's rich sporting history, including centuries-old indigenous sports, our national and regional sporting heroes of the past and how traditional Indian lifestyle activities hold the key to a Fit Life for All. The Fit India Quiz has a total cash award of Rs 3.25 Crore which is distributed among the schools and students.

- 1.2 The Fit India Quiz has three phases:
 - Phase 1 will start with a nationwide registration by schools followed by a selection of teams for the State/UT rounds through a Mobile App based online test.
 - Phase 2 will comprise State/UT rounds where the schools selected in the State/UT merit list shall compete for the State/UT championship.
 - Phase 3 will have a National Round in which 36 State/UT champions will compete for National Championship. This round will be broadcasted on the National Television.
- 1.3 In the first edition of Fit India Quiz held in 2021, 36,299 students from 13,502 schools participated in the preliminary round and showcased their knowledge in fitness and sports. The State round witnessed 360 schools competing among themselves for the crown of State/UT Champions. The 36 State/UT Champions further competed for the title of National Champions of Fit India Quiz.

Subsequently, in the second edition launched on 29 August 2022, a total of 61,981 students from 16,702 schools across 702 districts participated in the mobile based Preliminary Round which was conducted by National Testing Agency (NTA). Thereafter, 348 schools were selected for the State/UT round, those competed in 120 web rounds and 36 State/UT winners were identified. Under the component Sports Competition and Talent Development of Khelo India Scheme, eight editions of Khelo India Games namely; (i) Khelo India School Games New Delhi, 2018 (ii) Khelo India Youth Games Maharashtra, 2019 (iii) Khelo India Youth Games Assam, 2020 (iv) Khelo India University Games Odisha, 2020 (v) Khelo India University Games Karnataka, 2021 (vi) Khelo India Youth Games Haryana, 2021 (vii) Khelo India Youth Games Madhya Pradesh, 2022 (viii) Khelo India University Games Uttar Pradesh, 2022 have been successfully conducted so far. The next edition of Khelo India Youth Games & Khelo India University Games are scheduled to be held in Tamil Nadu & Assam respectively.

- 2.
