## Notice Inviting Applications from eligible candidates for appointment of Chief Coaches on contract basis

Sports Authority of India invites applications in the prescribed format from eligible candidates for appointment on contract basis as Chief Coach for an initial period of one year and extendable in cycle of one year subjected to maximum age of 65 years (subject to yearly performance evaluation) as detailed below:-

- \* Number of vacancies is indicative and SAI is at liberty to appoint Chief Coaches based on workload.
- \* These vacancies can also be utilized for TOPS NCOE.

## 2. Last date for receipts of online application is 28-04-2022.

3. Eligibility for Chief Coaches to be recruited under Contract

4. Pay and tenure for Chief Coaches to be recruited under Contract:-

Contract can be extended upto 65 years subject to yearly performance review.

## **5.** Selection procedure:

- (i) Through interview including oral test for discipline specific knowledge. In case, number of candidates are more than five times of the vacancies, short-listing of candidates for interview shall be carried out on the basis of approved criteria. Hence, mere fulfillment of eligibility criteria does not entail the candidate to be called for the interview.
- (ii) The list of eligible shortlisted candidates for interview along with date(s) and place of interview will be posted on SAI website.
- (iii) The Candidates should note that their candidature at all the stages shall be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after Interview, it is found that they do not fulfill any of the eligibility conditions; their candidature shall be cancelled by the SAI.
- **6.** The term International Participation, as mentioned at S. No. 3, means having represented the country in the International competition at Senior Level in Sports discipline recognized by World Body of the respective Sports such as:
  - i)Olympic Games
  - ii)World Championships / World Cups
  - iii) Asian Games
  - iv)Commonwealth Games
  - v) Asian Championships/ Asia Cups

The above definition will be considered as a standard/ benchmark while working out the eligibility of all the applicants those have applied under the category of International Participation.

- 7. The engagement of coaches on contract basis shall not confer on them any right for absorption or appointment on regular basis in SAI.
- **8.** The Sportspersons (Ex- International Athletes) inducted under contract as Chief Coach will be required to devote full time to coaching and hence, it is advisable that only those sportspersons, who can devote full time for coaching should apply. They may have to undergo various short term/ medium term training / orientation programme.
- **9. How to Apply**: Through <u>online Application Form</u> available on SAI website <a href="https://sportsauthorityofindia.nic.in/saijobs">https://sportsauthorityofindia.nic.in/saijobs</a> Applications received through any other mode shall not be accepted and summarily rejected.

**LAST DATE FOR RECEIPT OF APPLICATIONS**: The schedule for applying online is given below:-

- i. Date of opening of online registration **15.04.2022** from **05:00PM**
- ii. Closing date for submission of online application 28.04.2022 till 05:00PM
- 10. All relevant certificates shall be mentioned in the online application form and uploaded accordingly. Certificates not mentioned in the application form shall not be accepted in any form after the last date.

- 11. Last pay drawn document: Candidates shall get their monthly remuneration document from their previous employer. If the last pay drawn is more than the remuneration mentioned in the advertisement, then pay may be fixed accordingly subjected to a maximum of Rs 2, 25,000. Further in case of an exceedingly deserving candidate suitable remuneration shall be decided by SAI subject to maximum of Rs. 2,25,000/-.
- **12.** Relaxation in Age limit for SC/ST/OBC/Ex-Serviceman shall be as per DoPT OM No. 15012/2/2010- Estt(D) dated 27.03.2012.
- **13.** Proof of age and caste certificate may be issued in accordance with the DoPT OMs as mentioned below:-
- a) Proof of Age OM No. 19017/7/79-Estt(A) dated 30.11.1979.
- b) Caste certificate
  - SC OM No. 36012/6/88-Estt(SCT) dated 24.04.1990, OBC – OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016
- **14.** Decision of SAI in all matters regarding eligibility, selection and posting would be final and binding on all candidates. No representation or correspondence will be entertained by SAI in this regard.
- **15.** SAI reserves the right to modify/alter/restrict/enlarge/cancel the recruitment process, if need so arises without issuing any further notice or assigning any reason thereafter. The decision of the SAI shall be final and no appeal will be entertained.
- 16. The coach selected in the grade of Chief Coach can further be converted to the grade of High Performance Coach if found suitable on the basis of assessment done by a duly constituted committee in SAI. The above conversion shall be subjected to fulfillment of eligibility conditions in SAI Recruitment Rules and availability of Vacancies.
- 17. The other terms & conditions necessary for appointment in SAI will be mentioned in the detailed agreement that shall be signed by the selected candidate at the time of appointment.
- **18. Termination**: The contract can be terminated by giving a 30 days notice period by either party i.e. SAI and the employee. In extreme cases the contract can be terminated by SAI with immediate effect without notice period.
- 19. Applications received after due date are liable to be summarily rejected. Sports Authority of India will not be responsible for any delay in the submission of online application form due to any reason.
