Notice Inviting Applications from Paralympian candidates for appointment at Senior Coach and Coach Grade on contract basis

Sports Authority of India invites applications in the prescribed format from Paralympian candidates for appointment on contract basis at Senior Coach and Coach grade for an initial period of four years (subject to yearly performance evaluation) as detailed below:-

3. Eligibility for Coaches to be recruited under Contract

Coaching experience in respective sports discipline

Maximum of one to each sports discipline in Paralympics games may be appointed.

4. Pay Range and tenure for Coaches to be recruited under Contract:-

Contract can be extended upto 65 years subject to yearly performance review.

Age relaxation upto 10 years will be applicable to person with Benchmark disabilities (PwBD) as per Government of India guidelines.

^{**} The Horizontal reservation will be followed while filling the posts with Paralympian.

5. Selection procedure:

- (i) Through interview including oral test for discipline specific knowledge. In case, number of candidates are more than five times of the vacancies, short-listing of candidates for interview shall be carried out on the basis of approved criteria. Hence, mere fulfillment of eligibility criteria does not entail the candidate to be called for the interview.
- (ii) The list of eligible shortlisted candidates for interview along with date(s) and place of interview will be posted on SAI website.
- (iii) The Candidates should note that their candidature at all the stages shall be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after Interview, it is found that they do not fulfill any of the eligibility conditions; their candidature shall be cancelled by the SAI.
- **6.** The term International Participation, as mentioned at S. No. 2, means having represented the country in the Para International competition at Senior Level in Sports discipline recognized by World Body of the respective Sports such as :
 - i) Paralympics Games
 - ii) Para World Championships / Para World Cups
 - iii) Para Asian Games
 - iv) Para Commonwealth Games
 - v) Para Asian Championships/ Para Asia Cups

The above definition will be considered as a standard/ benchmark while working out the eligibility of all the applicants those have applied under the category of International Participation.

- **7.** A panel of Coaches on contract shall be drawn and that will be valid for a period upto one year.
- **8.** The engagement of coaches on contract basis shall not confer on them any right for absorption or appointment on regular basis in SAI.
- **9.** The Sportspersons (Ex- International Athletes) inducted under contract as Sr. Coach / Coach will be required to devote full time to coaching and hence, it is advisable that only those sportspersons, who can devote full time for coaching should apply. They may have to undergo various short term/ medium term training / orientation programme.
- **10.** How to Apply: Through online Application Form available on SAI website https://sportsauthorityofindia.nic.in/saijobs Applications received through any other mode shall not be accepted and summarily rejected.

LAST DATE FOR RECEIPT OF APPLICATIONS: The schedule for applying online is given below:-

- i. Date of opening of online registration 22.08.2022 from 1700 hrs.
- ii. Closing date for submission of online application 04.09.2022 till 1700 hrs.
- **11.** All relevant certificates shall be mentioned in the online application form and uploaded accordingly. Certificates not mentioned in the application form shall not be accepted in any form after the last date.
- **12.** Decision of SAI in all matters regarding eligibility, selection and posting would be final and binding on all candidates. No representation or correspondence will be entertained by SAI in this regard.
- **13.** SAI reserves the right to modify/alter/restrict/enlarge/cancel the recruitment process, if need so arises without issuing any further notice or assigning any reason thereafter. The decision of the SAI shall be final and no appeal will be entertained.
- **14.** The other terms & conditions necessary for appointment in SAI will be mentioned in the detailed agreement that shall be signed by the selected candidate at the time of appointment.

- **15. Termination**: The contract can be terminated by giving a 30 days' notice period by either party i.e. SAI and the employee. In extreme cases the contract can be terminated by SAI with immediate effect without notice period.
- 16. Applications received after due date are liable to be summarily rejected. Sports Authority of India will not be responsible for any delay in the submission of online application form due to any reason.
