PUBLIC NOTICE

Subject: Continuation/Revival of Debarment of M/s Shiv Naresh Sports Pvt. Ltd. from participating in any Tender/Bid of Sports Authority of India (SAI), including on the Government e-Marketplace (GeM) portal, CPP Portal pursuant to Order dated 20.08.2026 of the Hon'ble High Court of Delhi in ARB. A. (COMM.) 61/2026.

- (iv) Order dated 08.06.2026 passed by the Ld. Sole Arbitrator under Section 17 of the Arbitration and Conciliation Act, 1996, staying the operation of the Termination Order and the Debarment Order.
- (v) Order dated 20.08.2026 passed by the Hon'ble High Court of Delhi in ARB. A. (COMM.) 61/2026, staying the operation of the Ld. Sole Arbitrator's Order dated 08.06.2026, till the next date of hearing.

1. Notice is hereby given for information of all concerned, including bidders, vendors and users of the Government e-Marketplace (GeM) portal, that the Sports Authority of India (SAI) had, vide Debarment Order dated 17.03.2026, debarred M/s Shiv Naresh Sports Pvt. Ltd. from participating in any tender/bid floated by SAI, including at its Regional Centres (RCs), National Centres of Excellence (NCOEs), Sports Training Centres (STCs) and National Centre for Sports Science and Research (NCSSR), for a period of one (01) year, on the grounds set out in the said Order.

2. The operation of the said Debarment Order (along with the Contract Termination Order dated 26.02.2026) was stayed by the Ld. Sole Arbitrator vide Order dated 08.06.2026 passed under Section 17 of the Arbitration and Conciliation Act, 1996, pursuant to which M/s Shiv Naresh Sports Pvt. Ltd. was permitted to participate in SAI's tenders during the pendency of the arbitral proceedings.

3. Aggrieved by the said Order dated 08.06.2026, SAI preferred an appeal under Section 37(2)(b) of the Arbitration and Conciliation Act, 1996 before the Hon'ble High Court of Delhi, registered as ARB. A. (COMM.) 61/2026. Vide Order dated 20.08.2026, the Hon'ble High Court has stayed the operation of the impugned Order dated 08.06.2026, till the next date of hearing, i.e., 07.10.2026.

4. Consequent upon the said Order dated 20.08.2026 of the Hon'ble High Court of Delhi, the Debarment Order dated 17.03.2026 stands revived and is operative with immediate effect. Accordingly, M/s Shiv Naresh Sports Pvt. Ltd. (including all allied firms, if any, associated with it) shall stand debarred/ineligible to participate in, or be awarded, any tender/contract of SAI, including on the GeM portal, till further orders.

5. This Notice is issued for updation of the debarment status on the SAI website, CPP Portal and on the GeM portal, and is subject to the final outcome of ARB. A. (COMM.) 61/2026 pending before the Hon'ble High Court of Delhi.
