During the meeting, the prospective bidders raised the following queries. The clarifications provided by the committee are tabulated below:

S. No.	Queries Raised by the Prospective Bidder	Clarification / Reply by the Committee
1.	The bidder sought clarification as to whether registration under the Madhya Pradesh Shop and Establishment Act, 1958 (Gumasta) is mandatory.	The Committee clarified that submission of the registration certificate under the Madhya Pradesh Shop and Establishment Act, 1958 (Gumasta) is mandatory, as per the terms and conditions of the tender.
2.	The bidder sought clarification on whether a provisional turnover certificate would be accepted in place of the prescribed turnover certificate.	The Committee clarified that a provisional turnover certificate duly certified by a Chartered Accountant (CA) shall be accepted.
3.	The bidder sought clarification as to whether exemption from the experience criteria would be available.	The Committee clarified that bidders registered under the MSE category or registered under the relevant category, as applicable under the tender conditions, shall be eligible for exemption from the experience criteria.

4.	The bidder sought clarification whether a non-empanelled bidder can participate in the Limited Tender after empanelment.	The Committee clarified that only empanelled bidders shall be eligible to participate in the Limited Tender. A non-empanelled bidder shall not be eligible to participate.
5.	The bidder sought clarification as to whether L1 would be determined through the QCBS method or the LCS method after empanelment.	The Committee clarified that L1 shall be determined based on the Least Cost Selection (LCS) method, as prescribed in the tender terms and conditions.

During the meeting, the Chairman of the Committee further highlighted the important terms and conditions of the tender for the benefit of the prospective bidders.

The committee recommended publishing the above clarification for information of all prospective bidders.
